I. Call Subcommittee Meeting to order Dr. Knapp called the meeting to order at 6:30 pm.

II. Acceptance of Minutes

A. November 10, 2015

III. Public comment regarding items on the agenda

There were no public comments regarding items on the agenda.

- IV. Items for action/Discussion
 - A. Curriculum review cycle
 - 1. Science & Technology/Engineering

Dr. Fortin presented the update. They have started a multi-year curriculum review. Started with #1 and #2 frameworks, draft came out 3 years ago. Standards accepted in January by state. Technology and engineering standards in the MCAS 2019 test. These are PreK – 12.

2. Digital Literacy & Computer Science

Standards released by the state, they are proposed not adopted. These standards would include programming, typing, research, and digital citizenship. This would be limited by the technology available to the schools.

B. MA Math & ELA Frameworks

Frameworks for Social Studies and Music next year, then Math and Foreign Language after. Looking to work on 1 -2 curricula each year.

Currently math standards are not common core. Common Core may be repealed by the state.

C. Assessment

1. DDM Update

Dr. Fortin noted all the DDMs for the district collected in a database. There is a lack of professional development and they are out of time this year. He is looking for time to provide feedback of DDMs to the teachers.

Subcommittee discussed formative assessments, portfolio assessments, program assessment, high quality assessments for data, and how to integrate assessments. Dr. Fortin noted the district will be taking PARCC next year with the BHS using MCAS. Many districts that used online PARCC last year are switching to paper this year. Dr. Laughner questioned when the hybrid MCAS would be out. Dr. Fortin noted it should be next school year with an online based test.

2. PARCC/MCAS update

Dr. Knapp asked about a data dashboard. Dr. Fortin noted there are pockets of data everywhere but we don't currently have that dashboard. Dr. Fortin is looking on PD to make the best use of data teams. He is looking to make sure we are collecting good data and put it in place to use. Dr. Knapp referenced back to 2008 paperwork that had similar recommendations as the current recommendations. The subcommittee discussed how to communicate to the public areas of concern and how information gets shared during school transitions.

D. Goals/Future direction

Dr. Laughner noted things for discussion;

- open ed resources
- flipped classrooms Dr. Fortin noted blended learning
- learning space changes
- portfolios
- 7th grade honors math

Committee noted to discuss at next meeting, open ed resources.

E. Question of expanding membership

Dr. Fortin questioned if the subcommittee would like anyone invited. The committee did not suggest at this time.
