A. Swift River Elementary – Progress report on school improvement plan Mr. Kuhn updated the Committee on the progress with the SRE school improvement plan. Mr. Kuhn noted some of the efforts implemented are; DIBELS staff training, CBM math assessment, data teams. 1XL program for math, inclusion consultant, PeaceBuilder program, lunch/recess para training, pilot "Acting with Purpose' program in 11 classrooms, social skills curriculum, climate surveys. He noted that they are still looking for more collaborative time. Mr. Fritsch thanked them for the presentation; he also noted that it effectively showed what they were doing and what they were working on. Dr. Knapp asked about collaborative time and inclusion classrooms. Mr. Kuhn noted there are 3 inclusion classrooms. Ms. Farrington presented the Committee with an update on her lunch/recess DDM. The SRE enrichment program ran last semester and will run for the next semester during recess. These programs were widely appreciated and had excellent attendance. Ms. Farrington noted that at this age level structured time is helpful. She also noted there is an adult in every classroom during indoor recess.
