Mr. Fortin spoke to the DDM assessment. Mr. Fortin spoke with grade leaders and department heads with regard to DDMs. He noted there are three thing they are looking at;

- Mr. Fortin and the district looking at where we are, what currently exists, what teachers are using, MCAS or PARCC.
- The district compliance Mr. Fortin is responsible to report teacher impact rating
- Using the DDM in a way that is informative and how do we use data for this purpose.

Mr. Fortin noted that the January professional development day would be in part used for DDM assessment.

The Committee discussed the uses of data in the district and the collection of data.

Dr. Laughner questioned the effective goals for art and music. It was noted there are more being developed. Dr. Knapp questioned the student growth – he referenced data with regard to opportunities available to students in the district. Dr. Laughner questioned the use of student portfolios. Mr. Fortin noted that he is looking into what the district is currently using and determining what will be the most effective. Mr. Fortin also noted that if MCAS data is used consistently and effectively, from grade to grade, it can be helpful to determine what worked, what needs to be worked on, and diagnostics.
