- Call Subcommittee Meeting to order
 Dr. Knapp called the meeting to order at 6:00 pm.

III. Public comment regarding items on the agenda

There were no public comments regarding items on the agenda.

IV. Items for action/Discussion

Success for Every Student Every Day

A. Curriculum review cycle

Dr. Fortin presented. He noted they moved Guidance up along with PE. Dr. Fortin wanted it noted that with the present budgeting process, it is not a battle between science and music. The district schedule has science and technology to focus on first, music is on the cycle for 2019. The science budget was changed from \$45,000 to \$18,500.

Dr. Laughner questioned the 4-5 assessment. Dr. Fortin noted that hopefully teachers are keeping track. A 2017 Science/Technology committee is being formed. Looking by year 3 to not need Dr. Fortin to oversee any longer. Science/technology frameworks are new. There are big gaps in the new frameworks. Some content going from grade 8 to grade 7 and grade 3 to grade 2.

Dr. Knapp noted it would be helpful if it was communicated to teachers and parents exactly what administration does.

B. Competency-based education (Tacoma Model)

Dr. Knapp questioned the Tacoma Model and how we get beyond state standardized testing. Dr. Fortin noted this is part of his plan. With new frameworks some components of standards cross curriculum, such as math practices, science practices. There is some similarity across each. At the next meeting, discussed should include district leadership to look at establishing common themes. The committee discussed how to develope competency and opportunities to add other things that might be important. The committee discussed what Dr. Fortin had done in his prior district. Dr. Fortin noted that is is a similar situation.

C. Open education resources

Dr. Fortin spoke about a digital literacy group. Some of the resources being used are Kahn Academy and PBS. There doesn't seem to be any framework that they are choosing. Superintendent Coffin noted it is not organized as yet. The committee discussed other avenues to pursue with regard to online resources. It was noted that Massachusetts has an open depository which was not utilized much. Dr. Knapp questioned what the advantages of open ed would be. Dr. Fortin noted; cost, availability, acuracy, interactive, in some cases immediate assessment. The committee discussed some of the resources that teachers are currently using, power school, google classroom at JBMS, class dojo, are some.
