- I. Call to order
 Dr. Tsoumas called the School Committee meeting to order at 6:30 p.m.
- II. Finalist Interview for position of Superintendent of Schools Ms. Lynn Ann Clark, M.Ed. Ms. Correira introduced the Superintendent candidate, Ms. Lynn Ann Clark, who was present to be interviewed by the School Committee. She then turned the meeting back over to Dr. Tsoumas, who welcomed Ms. Clark and read an opening statement as to how the interview would proceed. The format of the interview consists of three parts: opening remarks by the candidate; seven prepared questions from the Committee members; closing questions and/or comments by the candidate.

Ms. Clark began with a discussion of her site visit today throughout the district, and the reasons for her continued strong interest in the position of Superintendent. The School Committee members then asked questions in turn with regard to resolving issues, curriculum development, management style, past experience with Student Support Services, community relations, learning from mistakes, and budget issues. Ms. Clark responded thoroughly and thoughtfully to all questions, often providing specific examples of her own experiences in these areas. She then asked the School Committee members to discuss their reasons for sitting on this board and to elaborate on their goals for the district. Ms. Clark closed her remarks by thanking the School Committee for the opportunity to interview for this position and gave several reasons for her desire to serve as Superintendent.
