Minutes

Pledge of Allegiance

Call to order

Mr. Fritsch called the meeting to order at 4:30 pm.

- Public comment regarding items on the agenda
 There were no public comments regarding items on the agenda.
- III. Unfinished business

A. Discussion and Vote on FY 2017 School Department Budget (A.I.)

Motion: Ms. Bogdanovich moved to go with the tier 2 option with hockey being added

as a tier 4. Amended with wrestling as tier 1 under option 2.

Second: Ms. French

Vote: 4,0,0

Discussion: Dr. Knapp looked at athletics and noted some programs lower numbers if you raise the fee it might push them out. Lower participation should have lower fee. The Committee discussed the fees for football and hockey. Ms. French note the football booster club helps. Dr. Knapp noted that some student will not take advantage of support that may be offered. Ms. French does not think a higher fee will hurt the football program. The Committee discussed the wrestling program and lack of interest. Dr. Knapp noted that once you lose a sport program you lose opportunity for students. The Committee discussed what the increase would be to revenue if fees were increased.

Motion: Dr. Knapp moved to increase the parking fee to \$125 and to keep transportation fees the same.

Second: Ms. Bogdanovich

Vote: 3,1,0

Motion: Ms. French moved to raise the music rental fee from \$40 to \$50

Second: Ms. Bogdanovich

Vote: 4,0,0

Discussion: The Committee discussed a raise in fees for parking and music instrument rental. Dr. Knapp noted that there are more issues with students who drive to school than those that ride the bus. Parking fees could only be used for parking lot maintenance and snow removal. The Committee discussed transportation fees; it is listed separately in the town's budget but comes out of the school's budget. Ms. French noted the increase should be across the board.

Motion: Ms. Bogdanovich moved to approve \$27,734,631 budget

Second: Dr. Knapp

Vote: 4,0,0

Discussion: Ms. French noted that the School Committee can discuss a list of priorities but cannot tell the Superintendent what she can put in the budget. Dr. Knapp appreciated the change in staff reductions. Dr. Knapp noted this is a number the town can afford

Discussion: Mr. Fritsch noted he would hate to give up the music program. Music teaches math, history, and English. Mr. Dunn noted there was \$1,050 collected in fees this year. Dr. Knapp requested Ms. Smith (JBMS band director) to elaborate on the instrument repair. Why is cost so high. Ms. Smith noted that all the schools own percussion instruments that need repair those are not rented out to students so there are no fees collected. It was noted that there are 120 students in the 5th grade band. Dr. Knapp suggested there may be another opportunity for music at 5th grade level. The Committee questioned the number of student involved in band. That number was not available.
