#### Minutes

- Call to order
   Mr. Fritsch called the meeting to order at7:00 pm.
- II. Public comment regarding items on the agenda There were no public comments regarding items on the agenda.
- III. Special awards and presentations

  There were no special awards or presentations.
- IV. Update from BHS Student Advisory Council representatives CSS: Annual walk-a-thon October 1, sponsored by the PTO

**SRE**: Grades 2 & 3 will be offered enrichment activities at recess, 30 minutes of non-academic activities October 13-18.

CHCS: Fire prevention & safety month. Fire fighters will be coming in for presentations.

JBMS: Running club starts this week.

**BHS**: Non-perishable food drive going on. Vision meeting took place on Monday. Band will be going to the Big E to perform. Belchertown Fair was a successful fundraiser. Freshmen and sophomores had the parking lots, junior booth raised about \$4,400 and the senior booth raised about \$3,000.

## VI. Reports and recommendations of the Superintendent

A. Superintendent Goals (pending Subcommittee discussion)

Superintendent Coffin introduced Pat Martin, her coach in the new superintendent induction program. Superintendent Coffin presented her goals to the Committee. The goals consist of:

- Student learning
- Professional practice
- District improvement = 2 goals

The Committee discussed the set up and wording of goals. Superintendent Coffin will update and bring back to next meeting.

### Dr. Knapp arrived during this discussion.

B. School Choice and District Enrollment Update

Superintendent Coffin updated the Committee on the school choice seats. The total new seats filled were 40, total school choice students in district is 123. Superintendent Coffin updated the Committee on student enrollment, 2,395 students in district. It was noted that BHS was designed for 1,000 students.

#### VII. Personnel Update

Superintendent Coffin updated the Committee on the new hires in the district, including CHCS-food service, BHS-long term PE sub, JBMS-Gr. 8 SPED teacher, and a District-speech/language path assist.

#### VIII. Unfinished business

A. MASC Policy Contract (A.I.)

Motion: Ms. Bogdanovich moved to approve the MASC policy contract pending technology language change.

Second: Ms. French

Vote: 5,0,0

Discussion: Superintendent Coffin presented the revised contract. Dr. Laughner noted the technology language about browsers was not amended. The Committee requested the browser language be removed from the contract.

#### IX. New Business

A. Snow Plowing Bid (A.I.)

Motion: Ms. Bogdanovich moved to approve the GTC Landscaping bid for snow plowing.

Second: Dr. Knapp

Vote: 5,0,0

Mr. Lachance presented the recommendations for snow plowing. Six packets were sent out and the district received 3 bids. GTC was the lowest bid. Mr. Lachance recommends approval of GTC. Ms. French asked for clarification of the charges and what happens if

the plowing conflict with the company's other obligations? Mr. Lachance explained the school would take precedence. This is a 1 year bid with 2 one year extensions; there would be no more than a 5% increase.

B. Healthy Hampshire survey request (A.I.)

Motion: Ms. French moved to take no action

Second: Ms. Bogdanovich

Vote: 5,0,0

Discussion: Mr. Fritsch presented a request from Sarah Bankert to use the district survey system for a survey of the RT 202/State Street. Dr. Knapp spoke to the request. Ms. Bogdanovich noted there are 2 other surveys going out soon for the district. The Committee discussed the use of the school survey system to an outside organization. It was suggested that the request be sent to the Property & Transportation Subcommittee to look at. The survey would discuss the State School property and access to Rte 202 by the school entrances.
