## **MINUTES**

Call to order
Dr. Tsoumas called the School Committee meeting to order at 5:00 p.m.

- II. Superintendent Search Discussion with Pat Correira
  - A. Review of advertising materials-brochure and print ad
    - Ms. Correira presented a draft of information for the Education Weekly advertisement, followed by a discussion of its content with present School Committee members.

MOTION: Dr. Knapp moved to approve the content of the Education Weekly advertisement, as presented. Ms. Popowich seconded the motion. VOTE: 3-0-0, approved unanimously

 Ms. Correira presented the publicity brochure to be used for mailings, followed by a discussion with School Committee members, and revisions were noted. It was decided that a vote on the "key responsibilities" section in the brochure will follow the discussion of the survey and focus group results.

MOTION: Mr. Fritsch moved to approve the publicity brochure for mailings, as amended with revisions noted. Ms. Popowich seconded the motion.

VOTE: 4-0-0, approved unanimously

B. Review of survey and focus group results

Ms. Correira provided a handout detailing the results received from the survey and focus groups, and a discussion ensued regarding these results. 181 respondents participated in the online survey, and characteristics of the next superintendent were highlighted from the responses. Points that were reinforced in those responses included the following: communication, successful educational experience, curriculum and instruction experience, and knowledge of school safety. Based on these results, there were no additional points added to the "key responsibilities" section in the brochure.

MOTION: Mr. Fritsch moved to approve the Key Responsibilities section in the publicity brochure for mailings, as presented. Dr. Knapp seconded the motion.

VOTE: 4-0-0, approved unanimously

C. Appointment of Superintendent Screening Committee

A worksheet was provided to record the Superintendent Screening Committee as it was selected. Ms. Correira announced the segments of the committee that were determined by the minimum number of volunteer applicants: administration, community, and the elected town official.
